

Priority Areas



DIVERSITY

We encourage programs and activities that promote peace and harmony, support refugees to integrate into the community and support all people who are marginalised in the community to create more social connectedness.

HEALTHY COMMUNITIES

Council aims to deliver affordable exercise activities and promote educational programs and activities, health and nutrition, wellness and social connectedness.

SAFE COMMUNITY

We value programs that encourage safer communities and which promote Fairfield City as a safe and secure City.

Priority Areas



INCLUSIVE

We want a community that improves the quality of life for all residents, including people who are marginalised. We also support programs that lower the cost of community services and facility use and provide financial and education support where most needed.

LIFELONG LEARNING

We encourage lifelong learning and training for all members of our community and support programs that provide job support, and develop children and youth.

SUPPORTING DISABILITY

We encourage positive community attitudes and behaviours towards people with disability and support organisations that employ people with a disability and deliver accessible and inclusive events.

Eligibility



WHO IS ELIGIBLE?

- Applicants must be an incorporated not-for-profit organisation based and operating within the Fairfield Local Government Area and/or principally service Fairfield residents
- Non-incorporated groups may ask an incorporated organisation to auspice an application. That organisation will then be responsible for managing the funding
- Projects which meet at least one of the priority areas

Eligibility



WHO IS NOT ELIGIBLE?

- Religious activities or entities in which the promotion of a single faith is the main purpose
- Political events and programs
- Government organisations or agencies
- Educational institutions wanting to supplement their activities
- Private organisations or those seeking commercial gain; either directly or through an auspice or contracting arrangement

Eligibility



WHO IS NOT ELIGIBLE?

- Organisations wanting to top up shortfalls in budget
- Activities and programs that duplicate existing services or repeat previously funded projects
- Projects that seek funding for the sole purpose of purchasing equipment.
 Council's donations and funds program may be suitable for this purpose
- Applicants for competitions, prize money, and/or trophies or for the promotion or celebration of national or independence days

Fine Print





Read the guidelines carefully!

Fine Print



- The funding sought can't be used to pay salary staff. Funding can be used to pay facilitators and consultants for the purpose of the project
- Applicants must not have outstanding project acquittals
- Projects must be open to all members of the community, especially people with disability
- Applications must disclose whether the activity is subsidised or freely provided. If subsidised, the cost to participants must be provided
- Only one application per activity/program can be submitted to Council in each funding category
- New projects are encouraged
- Council encourages funded programs to be free of charge or low cost to participants. Any proposed charge to participants, must be reflected in the project budget as income

Aged and Disability



These grants aim to support organisations such as:

- Aged or Senior Services
- Disability Support Services
- Carers Support Services
- Mainstream community organisations that support people who identify as a person with a disability, their carers or are seniors.

The program/project/event that you are applying for cannot be already funded by NDIS or My Aged Care (or any other government body)

Supporting those who "fell through the cracks":

- People with a disability that does not meet the eligibility criteria for the NDIS or
- People with disability or seniors who do not necessarily need assistance with everyday activities





Aged and Disability



Activity types

- Projects addressing social disadvantage or social isolation
- Building community connections and capacity (introducing support services, etc)
- Raising awareness of disabilities and ageing within the wider community

Priorities

- Projects that encourage positive community attitudes and behaviours
- Activities that improve independence and living skills for people who do not receive NDIS or my Aged Care
- Days of Celebration ex. International Day of People with Disability (Tuesday 3 December 2024) or Carers Week (13-19 October 2024)
- Projects that support carers

Youth Week



Held in April, Youth Week is an annual celebration of young people, organised by young people for young people.

Youth Week activities aim to provide fun and free activities with young people at the centre, celebrate local youth culture and provide opportunities for active participation.

Youth Week dates and themes are set each year by the NSW Government in consultation with the NSW Youth Advisory Council. Youth Week activities may be incredibly diverse, but all reflect Youth Week values.

Youth Week 2024 is 11-21 April Theme: *Express, Empower, Get Loud!*

*Grant round opens in Sept for events in 2025 Youth Week (9 April – 17 April)

Youth Week



Further considerations

- Funding must only be used for Youth Week events during the designated timeframe
- Applications should align with Youth Week values (found on the NSW Youth Week website)
- Young people aged 12 24 must be meaningfully engaged in the planning and delivery of all Youth Week activities
- Applications which only list young people as passive participants (not actively involved in the project will not be considered).

Total amount of grant sought must not exceed \$3,000

Tips for Designing a Youth Week Initiative



Tips

- Events must be <u>youth-led</u>. Engage young people early and from the start. Don't assume what young people need or want – speak with them!
- https://www.acyp.nsw.gov.au/top-10-tips-for-participation
- Think about how young people are engaged in planning and what benefit they may get out of it. Include this in your application
- Consider accessibility. How can your initiative be inclusive of people with diverse needs

Total amount of grant sought must not exceed \$3,000

Arts and Culture



The grants are open to all art forms, including film, visual art, music, literature, dance, theatre, digital media, augmented reality, virtual reality, and multi-disciplinary arts with a focus on assisting emerging and professional artists and art organisations in the development and production of work relevant to Fairfield.

Activity type

- Development of new artist-run initiatives
- Workshops and talks that boost creative skills
- Exhibitions, performance and events

Priorities

- Projects that support Aboriginal and Torres Strait Islander Culture, developed and led by community needs
- Work celebrating the diversity of cultures in the area
- Employ and partner with local arts and cultural practitioners

Total amount of grant sought must not exceed \$3,000.

Community Capacity Building grants support emerging needs within our community and projects that facilitate and build community connections and capacity. It's a good source of funding to try a pilot or develop an innovative solution.

Activity type

- Projects addressing social disadvantage and inclusion
- Building community connections and capacity
- Facilitating education/ employment opportunities
- Encourage community participation in the development and delivery of projects and activities

Total amount of grant sought must not exceed \$3,000.

- For projects and activities that strengthen positive, equal and respectful relationships between girls and boys or women and men
- For projects that raise awareness during 16 Days of Activism Against Gender-based Violence (25 November to 10 December)





Domestic and Family Violence Prevention



Activity type

- Highlighting achievements of refugees
- Highlighting ways to create a safer community
- Refugees are actively involved in the planning and delivery of the activity.

Creative Communities





The Creative Communities Grant supports projects that empower communities to voice important issues, while further developing cultural knowledge and artistic skills. These projects need to be co-designed and co-delivered with community.

The grants are specifically for Community Arts and Cultural Development (CACD) Projects that address social issues through art. Total amount of grant sought must not exceed \$5,000.

Creative Communities



A Community Arts and Cultural Development Project has to meet ALL of the following criteria:

- Community-based arts project that uses any type of art form e.g. dance, theatre, visual arts, gaming, creative writing, music, filmmaking, etc.
- Collaboration between professional community-based artist(s) facilitators and local communities to create art that addresses a social issue.
- A series of workshops and/or activities that are led by local communities for Fairfield residents.
- The project must consider CACD principles of inclusion, access and equity, personal growth, sharing of knowledge and skills and artistic integrity. The community holds the creative agency of this project. It's guided by our community.

Creative Communities



What a Community Arts and Cultural Development Project is NOT:

- One-off cultural event or concert
- Creation of new work that is not participant driven and artist facilitated

Selection Criteria



APPLICANTS WILL BE SELECTED THAT BEST SHOW:

- A commitment to inclusion
- Active participation and engagement
- A sound budget and implementation plan
- Accessibility for people with disability
- At least one of the identified outcomes outlined in the priority areas
- Commitment to the principles informing the grants program
- Direct benefit to people and communities in Fairfield City
- Evidence of good governance and insurances where relevant
- The project is achievable within a one-year period of receiving funding

Top tips for your application



- Ensure you address Council's priority areas
- Ensure you address the priority areas for the specific grant
- Make a case with statistics or evidence about why your project is needed
- Show us how the community will benefit from the project
- Complete the online SmartyGrants application and make sure you check it for spelling and grammar
- Work with others in the community to help deliver your project
- If the project involves children, all people over 18 years must have a valid Working with Children Check (WWCC). The organisation must ensure they have confirmed the status of each WWCC

Frequently Asked Questions



HOW MUCH MONEY CAN WE APPLY FOR?

No more than \$3,000 in the community grants program. In the Creative Communities Grant program the maximum grant is \$5,000.

WHEN WILL WE FIND OUT IF WE ARE SUCCESSFUL? WHEN WILL WE RECEIVE THE FUNDS? WHEN CAN WE RUN OUR PROJECT?

You will be notified of the outcome of your application once Council has made a determination. Successful applicants will be emailed and a funding agreement will be provided. Once this is signed, funds will be made available and you can begin your project.

WE RECEIVED FUNDING LAST YEAR. CAN WE APPLY AGAIN THIS YEAR?

Yes. As long as you have completed all your acquittals you can apply for more funding in each of our categories.

CAN WE PUT IN MORE THAN ONE APPLICATION THIS YEAR?

Yes. We have a number of different categories. Some have two rounds each year. You can apply for any category as long as you have a project that meets the requirements of the funding. You can't submit more than one application for the same grant 'category' e.g. 2 applications for Community Capacity Building. However, you can submit one application for each grant category, e.g. 1 application for Youth and Community Capacity Building.

Frequently Asked Questions



CAN TWO GROUPS APPLY FOR THE SAME PROJECT?

Two organisations can't apply for the same project, even if it's for different parts of it. Council will only make one contribution to a project. An organisation can be a partner in more than one project.

CAN MY ORGANISATION CHARGE AN ADMINISTRATION FEE FOR MANAGING THE GRANT?

We are only providing small grants to organisations so there is not much capacity to pay an administration fee. At the most, you could claim 5% for administration.

OUR ORGANISATION IS BEING AUSPICED BY ANOTHER. WHAT DO WE HAVE TO DO?

The auspicing organisation is responsible for submitting and managing the grant. Make sure you have a clear agreement with them around the project and your responsibilities. The auspicing organisation will need to sign the funding agreement and acquittal.

Frequently Asked Questions



CAN WE EMPLOY A NEW STAFF MEMBER?

The grants are not suited to employing a staff member or covering salary costs for project delivery. However, they can be used for a facilitator or group leader on a short-term contract.

DO I HAVE TO GET OTHER SOURCES OF FUNDING?

This one can be difficult as you might have multiple sources of funding for one project. Let us know if you have sought funding from elsewhere so we can make an informed decision.

DOES MY APPLICATION HAVE TO INCLUDE GST?

All funding sought will be GST free. In your budget the total amount sought will not include GST. However, at time of payment Council will add the 10% GST to your application.



Project Objectives

Must be no more than 50 words. What are you trying to achieve in this project? This may be outlined in the core aim of the project, e.g. To provide young people with access to support, information and referral when visiting the Fairfield Youth and Community Centre.



What to include?

- Refer back to your aims to ensure it aligns
- Unpack the 'who', 'what', 'where'
- They are often written as the practical steps and are the "how" of the project
- For example
 - Deliver two online workshops for up to 20 community and faith leaders to raise awareness of alcohol and other drugs

Evidence of Need How did you arrive at this objective? Please link your objective with a reference to evidence. E.g. "aligns with local/national strategies", "direct feedback from community", "consultations/survey results".

What to include?

- Include evidence about the needs of the target group/s and location/s – how was this need identified?
- Include data sources
- Refer to any consultations and/or evaluations your organisation has conducted in the past to inform the need and development of this project
- Refer to local/national strategies

Strategies

Must be no more than 50 words. This will include the activities and tasks that will be undertaken to achieve project outcomes. What methods will be used to involve the target group?



What to include?

- How you will achieve your Objectives?
- Include the activities and tasks that will be undertaken to achieve project outcomes

For example, this can include:

- Establish a weekly arts and crafts group
- Invite guest speakers
- Organise promotional materials
- Another key area to focus on is how you will involve and reach the target group?

Expected Outcomes

Must be no more than 50 words. Tell us the expected outcomes based on the project objectives. What are you trying to achieve with the target group? For example this can include increased skills, increased knowledge, increased connectedness to community.



What to include?

- What are you trying to achieve with the target group?
- When it comes to outcomes you might identify short, medium and long-term outcomes

Examples:

- young people report increased knowledge of local support services
- increased connection amongst participants
- This section is also important as you will report on it in your acquittal, and you need to be able to measure these outcomes!

Evaluations

How will you measure the impact of your project? Methods can include:

- Surveys
- Interviews
- Focus groups
- Testimonials
- Debrief with stakeholders involved
- Any other information that can measure the difference your project/event has made

Funding Tips


Do spell-check and grammar-check before submitting the application

Read the fine print

Contact the funder if unsure

Have a co-worker read your application prior to submitting it

Specify the who, what, when, where and why



Targeting the identified local needs

Demonstrate how your project will benefit/impact the local community and number of people benefited or impacted

Use plain English

Use relevant statistics and data to support your project proposal

Feedback on previous submissions

- Applicants had submitted unrealistic budgets
 e.g. applied for \$10,000 submitted which is over the grant limit
- Budget is not clear unsure what the funding will be spent on
- Project objectives are unclear or unrealistic the project lacks clarity and detail
- Not enough detail around who, what, where, when and why
- Unclear about how the project will target Fairfield residents
- No connection to the target group or lived experience to ground the proposal
- Not articulating evidence of need
- The application doesn't flow
- Underdeveloped evaluation to measure results
