FILE NAMING PROTOCOL FOR APPLICANTS AND CERTIFIERS



Purpose of the File Naming Protocol

When applying for an approval, such as Development Application, Construction Certificate and a Complying Development Application - compliance with the File Naming Protocol is encouraged in creating a PDF file as it enables the contents of your file to be clearly identified. This also assists with record keeping and access to information processes.

The following table lists the most common file names that applicants are encouraged to use.

Please note:

- i. Architectural plans (including site plan, floor plans, elevations, sections etc) may be submitted as 1 PDF providing the file size does not exceed 35 mega bytes.
- **ii.** Any PDF submissions exceeding 35 mega bytes, must be submitted as individual PDF's utilising the following file naming protocol.
- **iii.** This document contains 2 file naming sections 1 section specific for Private Certifiers and 1 section specific for applicants submitting DA's/CC's
