# Message from the Mayor and City Manager

Welcome to Fairfield City Council's 2014–2015 Annual Report.

This year has been challenging and exciting for Council with a requirement to respond to proposed local government reforms by the NSW State Government and continuing to provide quality services and new infrastructure for its community.

Council extensively engaged the community and responded in detail to the amalgamation option proposed by the NSW State Government as part of the Fit for the Future reform package.

With over 2,000 responses received from the community and businesses throughout the City results overwhelming support for Fairfield City to remain as a standalone Council. This was a major undertaking for Council with results of the detailed report provided by IPART stating that Council is financially fit into the future.

With a budget of more than \$154 million, Council delivered a wide range of services, major programs and projects throughout the City in order to continue to meet the community's needs and priorities as identified in the Fairfield City Plan.

The year has seen the completion and opening of the \$1.5 million Fairfield Adventure Park, a \$332,000 Bonnyrigg Town Centre Park upgrade featuring the longest double-flying fox in the City and commencing the construction of the \$8.5 million Fairfield Youth and Community Centre. These are just a few of the major projects that Council developed to provide affordable entertainment options for children, youth and families.

Work has also commenced on the multi-million dollar Dutton Lane development in Cabramatta. This development will provide retail and office space, community facilities and over 270 car spaces, delivering more parking and assisting Council to be more sustainable into the future.

Celebrating our diverse culture saw Council continue to provide the many unique, culturally rich and family friendly festivals for which it is renowned. These included events such as the Culinary Carnivale, Lunar New Year and Bring It On! Festival to name a few. Now in its 11th year, Council's Youth Week program, which features the

Bring it On! Festival, has been recognised at the Local Government Awards for the past five years, winning best local government Youth Week program for 2015.

Whilst delivering on the new and exciting infrastructure Council continued to deliver its major programs with over 16km of road upgrades and renewals through the City, construction of over 2km of footpath replacement and over 8km of new footpaths.

In order to make Fairfield a clean and attractive City, Council has implemented a number of programs including the suburb banners at gateways/intersections. These programs have seen several entry points to suburbs across the City enhanced with banners and landscaping to create an attractive welcome for people coming into the City and creating a sense of pride for residents.

Council also focussed on providing healthy and affordable lifestyle options for its community with a number of places throughout the City receiving upgrades, including Stockdale Reserve, Abbotsbury and Swager Place, Canley Heights. These upgrades included a circuit walking path, 665m shared cycleway, more active play equipment and healthy living programs delivered in parks.

With a focus on being more sustainable into the future Council installed solar panels to 19 of its buildings and recycled and distributed over 139 thousand tonnes of recycled construction materials producing savings in electricity and service costs whilst also providing additional income to Council.

We are proud of these and many other achievements we have implemented in order to meet the needs of our growing community and invite you to find out more details in the Annual Report.

# Fairfield City Profile

# FAIRFIELD CITY COUNCIL'S COMMITMENT TO ITS ABORIGINAL RESIDENTS

Fairfield City Council (Council) acknowledges the Cabrogal people of the Darug nation as the traditional custodians of Fairfield City and pays its respect to the Elders, both past and present. The Cabrogal name comes from 'cobra grub', an edible freshwater worm harvested from local creeks in our City. Council also recognises the spiritual relationship Aboriginal Australians have with the land and the right to live according to their own beliefs, values and customs.

In July 2000, Council signed a Local Government Commitment acknowledging and recognising Aboriginal and Torres Strait Islander people as the first people of Australia. It also acknowledged their loss and grief caused by alienation from traditional lands, loss of lives and freedom, and the forced removal of their children.

The signing of this significant agreement took place during National Aboriginal and Islander Day Observance Committee (NAIDOC) Week to symbolise our vital partnership with the Aboriginal and Torres Strait Islander people in Fairfield City.

#### **OUR HISTORY**

Our City is home to the Cabrogal people of the Darug nation. The Darug are indigenous people of Australian Aborigines which were united by a common language, strong ties of kinship and survived as skilled hunters in family groups or clans.

Our City was a great source of food for clans to live on for either weeks or even months at a time. The traditions and tribal law restricted the clans to take only what was necessary to survive. The arrival of the First Fleet in 1791 signalled major changes in how our landscape was utilised.

In the mid-1800s the land was used mainly for timber logging, farming and vineyards. Fairfield is named after the family estate of John Horsley - Fairfield Manor in Somerset, England to honour the family.








# Our Elected Representatives 2012-16



# Integrated Planning and Reporting Framework

The Local Government Integrated Planning and Reporting (IPR) Framework was introduced in NSW in 2009 to improve Council's long-term community, financial and asset planning. The IPR Framework ensures all Councils plan for a sustainable future for their community by addressing their needs and priorities as they identify them.

Fairfield City Council's IPR Framework is comprised of a number of plans; ten-year Fairfield City Plan, ten-year Resourcing Strategy, four-year Delivery Program and annual Operational Plan. The Reporting Framework includes the End of Term, Annual, Six Monthly and Quarterly Reports which talks about our progress against achieving the goals and priorities of our community.

#### FAIRFIELD CITY PLAN

The Fairfield City Plan is the Community's Strategic Plan, which has been prepared for Council through a series of community consultations. This Plan sets out the community's vision, needs and priorities for the next ten years, which are identified under the following five themes:

Theme 1 - Community Wellbeing

Theme 2 - Places and Infrastructure

Theme 3 – Environmental Sustainability

Theme 4 – Local Economy and Employment

Theme 5 – Good Governance and Leadership

#### RESOURING STRATEGY

The Resourcing Strategy includes three documents: the Long Term Financial Plan (money), Workforce Management Plan (people) and Asset Management Strategy (assets). It identifies how much of the community's needs and priorities Council can deliver, with the resources it has available.

#### REVISED DELIVERY PROGRAM (4 Years)

The Delivery Program is a high-level plan that sets out the projects, major programs and services Council has committed to deliver during its term of office, which works towards achieving the community's needs and priorities identified in the Fairfield City Plan.

Council has a Revised Delivery Program to include additional projects identified as a result of the Special Rate Variation approved by IPART, which took effect as of July 2014.

#### OPERATIONAL PLAN (1 Year)

The Operational Plan is a one-year plan that is developed each year providing the detail of the works identified for that year in the Delivery Program.

# Overview of Council Services

Fairfield City Council provides a wide range of services to the community. There are 40 services that work towards achieving the community's shared vision, goals and priorities identified in the Fairfield City Plan 2012-2022.

The services are split between external and internal services. External services relate to services that are delivered directly to the community. Internal services relate to corporate services that support the external delivery of Council services and seek to improve Council's efficiency, sustainability and accountability.

#### **EXTERNAL SERVICES**

#### Access to Information

Provide access to Council held information to the public in accordance with the Government Information (Public Access) Act.

#### Asset Management - Civil and Built

Monitor and maintain community assets to an agreed standard by undertaking condition inspections to identify and program any required maintenance and renewal works.

#### Asset Management – Open Space

Monitor and maintain open space areas and assets including parks, reserves, sportsfields, trees and public amenities.

#### **Built Systems**

Defines, develops and manages civil, urban and landscape infrastructure designs, manages Fairfield City's road network, including traffic management, transport and road safety programs with State Government entities, and provides surveying and spatial data services.

#### **Building Control and Compliance**

Performs the assessment, investigation, certification and enforcement of laws and regulations for developments within Fairfield City to ensure their health and safety.

#### **Catchment Planning**

Undertake studies to identify and plan measures to address flooding and stormwater issues across Fairfield City.

#### **CCTV Camera Program**

Design, install and maintain Closed Circuit Television (CCTV) program in public places and Council facilities across Fairfield City.

#### Children and Family Services

Provides quality children and family services including child care and early intervention programs to ensure a good future for our children and families within Fairfield City.

#### Civic and Councillor Services

Oversee the management and administration of processes and protocols for Council's formal decision making including supporting the elected representatives.



#### City Connect Bus

Provide a free City Connect Bus Service for areas that are poorly serviced by existing private bus routes and increase accessibility to key destinations and community facilities.

#### Communications and Marketing

Promote Council services and initiatives, and encourage community engagement through corporate publications, local, national, ethnic and social media as well as providing graphic design and printing services for Council's publications.

#### Community Enforcement and Regulation

Investigate and enforce regulatory and compliance laws within Fairfield City on community parking and companion animal issues.

#### **Customer Service Administration Building**

Delivers a centralised Customer Service Centre at the Administration Centre, which provides information and advice to customers via the front counter and call centre.

#### **Development Planning**

Conduct the assessment and processing of all development applications and engineering construction certificates across residential, commercial and industrial developments.

#### **Emergency Risk Management**

Provide leadership, assistance and resources in order to support emergency and disaster planning, response and recovery operations within Fairfield City.

#### **Environmental and Public Health**

Monitor and enforce regulatory and compliance laws within Fairfield City for environmental and public health standards.

#### Infrastructure Construction and Maintenance

Provide the construction, maintenance, repair, inspection and testing of Council assets - including fleet, plant, roads, signs, footpaths, drainage, kerbs, gutters, car parks, ovals and Council buildings.

#### Leisure Centres

Manage and maintain Council's three leisure centres, Prairiewood Leisure Centre, Fairfield Leisure Centre and Cabravale Leisure Centre and offer a range of aquatic and dry leisure services.

#### **Library Services**

Provide library services, including a wide range of resources, information, internet access, and programs at five locations within Fairfield City.

#### Museum and Gallery

Manage and maintain the Museum, Gallery and historic village as well as collect, preserve, educate curate and exhibit programs relating to heritage and historical value, cultural and public arts.

#### **Enterprise Risk Management**

Develop, implement and manage Council's Enterprise Risk Management Framework and the management of Council's commercial insurance function inclusive of general insurance renewals and insurance claims.

#### Major Projects and Construction Contracts

Project manage and coordinate the funding, design, construction and commissioning of major new community infrastructure, other civil and building construction, and special projects.

#### Place Management and Economic Development

Manage and coordinate initiatives, activities, policies and plans across Fairfield City in consultation with key stakeholders. Focus is on public domain improvements, economic development and sustainability, stakeholder engagement, processing minor activity applications and reviewing development applications.



#### **Property and Community Facilities**

Coordinates the management of Council owned properties and community facilities including community buses, sporting fields, community centres/halls, leased and licensed properties and multi-deck car parks as well as real estate functions to buy, sell, or lease land, grant easements and road closures.

#### Showground and Golf Course

Undertakes the management and maintenance of Fairfield Showground, Fairfield Markets, Fairfield Golf Course and the Parklands Function Centre.

#### Social and Cultural Development

Develop and implement policy, programs, capacity building and partnerships for the community in the areas of arts, cultural development, poverty, gambling, health, family services as well as crime and safety.

#### Strategic Land Use Planning

Identify, map and coordinate planning for residential, commercial and agricultural land across Fairfield City, as well as preparing zoning certificates and representing Council in rural and urban matters with State and Federal Governments.

#### Street and Public Amenities Cleaning

Provide the cleaning of streets and public amenities in the town centres, residential and industrial areas across Fairfield City.

#### Finanical Sustainability

Conduct the delivery of Council's financial services, analysis, advice and statutory reporting to ensure appropriate cash flow and long term financial viability.

#### Sustainable Resource Centre

Divert construction and demolition waste from landfill by recycling into marketable construction materials.

#### Waste Education and Environmental Sustainability

Provide and deliver educational programs and community sustainability initiatives for the community and Council.

#### Waste Management

Provides the management of domestic and commercial waste services across Fairfield City.

#### INTERNAL SERVICES

#### Corporate Planning and Improvements

Implement the compliance, coordination and development of the Integrated Planning and Reporting Framework (documents and reports) and corporate business improvements.

#### **Financial Operations**

Produce and issue the annual rates notices, management and processing of revenue collection and supplier payments for Council.

#### Governance

Ensure that Council maintains a sound system of internal control that supports Council's capability to fulfil its legal, financial and ethical obligations.

#### **Human Resources**

Provide strategic and operational human resources service including project management, industrial and employee relations, work health and safety as well as organisational and workforce development.

#### Information and Records Management

Manage Council's records and information including access, retrieval, storage and disposal.



#### Information Technology (IT)

Provide the implementation, maintenance and support of Council's information technology systems and infrastructures.

#### Procuement, Fleet and Stores

Develop, maintain and use competitive, transparent, accountable and ethical procurement and supply processes when the acquisition of goods and services are required to deliver Council services.

#### **Property Development Fund**

Provides Council with a self-funded Property
Development Fund for the purpose of generating
additional revenue through entrepreneurial real estate
activities and reinvested funds back into the community.





# ACHIEVEMENTS AND HIGHLIGHTS

### THEME ONE - COMMUNITY WELLBEING

## **FAST FACTS**

#### **Key Highlights**

- Opened the Fairfield Adventure Park which contains an 11 metre high giant climbing net, sky bridge and slide combination (one of the tallest of its kind in Australia) and a 33 metre long double flying fox.
- Constructed another circuit walking path in the City in Stockdale Reserve, Abbotsbury in its efforts to assist the community in being healthy and active.
- Completed concept designs for the Prairiewood Water Park which included things such as a unique surfing/skim boarding half pipe ride, adventure aqua tower and giant triple water slides.
- Installed CCTV cameras across Fairfield City in an effort to make Fairfield safer for its community.
- Held and supported more activities for youth with the Bring It On! Festival with over 10,000 young
  people attending from not only Fairfield City, but also other Sydney suburbs, who enjoyed music,
  sports and arts entertainment and activities at the Fairfield Showground.
- Won 'Best On-going Commitment to Local Youth Week' Award and 'Best Local Government Youth Week Program' for the Bring It On! Festival at the Local Government Week Awards.
- Funded a total of \$44,000 with the 'Social Change Through Creativity Grants Program', to 11 organisations that sought to improve social outcomes through creative processes in Fairfield City.
- Continued the Bike Recycling program which saw volunteers involved and working around 2,245 hours, which lead to over 280 recycled bikes loaned out to the community and 131 community rides conducted across the City, attracting over 2,700 riders.
- Provided free 'Learn to Swim' lessons for adults, mums and bubs along with children with a disability during Water Safety week at Council Leisure Centres.



#### **PROJECTS**

- The Fairfield City Library launched two new eBook platforms including the Baker and Taylor's digital media service and Axis 360. These platforms feature eBooks and digital audio-books online for residents to utilise.
- The Fairfield City Libraries implemented a new one-card 'tap and go' solution for bookings, printing and transactions to better meet the needs of the community.
- Fairfield Adventure Playground opened to the public with the construction of the 11m climbing net with sky bridge, three multi-directional slides and various swings.



- Improvements to the Wetherill Park Library included new carpet and benches, and re-arrangement of the shelving.
- A circuit walking path in Stockdale Reserve, Abbotsbury was constructed.
- Concept design for the Water Park has been completed and approved by Council. The design includes a surf simulator, splash and play area and giant multi-directional slides.
- An artist for the Time Line Wall at Fairfield City Centre has been recruited and concept designs completed.
- CCTV cameras were installed to address safety concerns across Fairfield City.

#### SERVICES

 The International 16 Days of Action to Eliminate Violence Against Women and White Ribbon Day were marked by two weeks of events and activities and attracted 5.000 residents.

- NAIDOC Week was celebrated by the Fairfield City community at two events, which included dance groups and art competitions to engage preschool and school aged children, with Aboriginal elders as judges.
- Aboriginal art and multicultural community exhibitions were launched at the Fairfield City Museum and Gallery, which included I Am Who I Am, a retrospective of the work of Aboriginal artist Robyn Caughlan and Happily Ever After: Wedding in the Multicultural City in collaboration with local community groups.
- Council diverted and mulched 310 cubic metre of tree branch waste from landfill.
- In partnership with Multicultural Health Services, Centrelink, MTC Australia, Afford Employment, The Smith Family and Max Employment, Council organised the "Healthy Workers are Happy Workers" workshop at Cabravale Leisure Centre. The workshop offered practical tips and advice to multicultural workers to stay healthy and well in the workplace.
- Council was highly commended by the auditors for its commitment to people with disabilities and for having a Quality Management System that underpins the NSW Disability Standards with 100% of the standards of practice met including things such as the Rights of People with Disabilities and Service Management.
- Fairfield City Markets are still very popular with over 600 stalls selling new goods, clothes, toys, sporting gear, jewellery and household items.



Fairfield City Council held a workshop about the National Disability Insurance Scheme for 100 community members with disabilities and their carers from diverse backgrounds.



- Fairfield Library delivered an 11 week training course to 80 students from across Fairfield City, on a range of Information Technology (IT) hardware and software skills required for future employment in IT.
- Council organised a Community Safety and Crime Prevention Campaign called 'Standing Together', which aimed to send a strong message that 'extremist behaviour should not divide the community'.
- Council's Senior Week Fair was attended by 600 people with access to 25 information stalls and interactive activities promoting senior services at the Fairfield Forum Shopping Mall.



- The Fairfield Youth Week Program delivered 12 activities at various sites across Fairfield City including a Multicultural Soccer Tournament at Villawood Village Fair, a Short Film Festival, Bring It On! Festival, and a shirt design competition.
- Volunteers worked 2,245 hours and recycled 284 bikes which were loaned out to the community. The volunteers conducted 131 community rides across Fairfield City, which attracted 2,723 riders.
- Council celebrated the start of National Reconciliation Week with the community in front of Council's Administration Centre, where a smoking and purifying ceremony was performed and all guests were invited to pass through the smoke to be cleansed.

• The Bring It On! Festival was a great success with a approximately 10,000 community members converging on the Fairfield Showground to enjoy free entertainment, information stalls and loads of activities for young people. Entertainment included X Factor winner Marlisa and The Pioneers, along with local groups such as Team 9Lives, Invincible Worldwide and With Confidence. As part of the planning stage, Council accepted 135 volunteers out of the 317 applications to assist in preparing and managing the Bring it On! Festival.



- Council held 33 Advisory Committee meetings that engaged and provided advice on Council programs or issues affecting the community such as funding cuts concerns for community groups, changes to Citizenship Legislation and preparing for the Bring It On! Festival.
- In partnership with NSW Health, Council distributed translated flyers in multiple languages about the new Smoking Legislation at the Cabramatta, Canley Heights and Fairfield Town Centres to better prepare the community and local business for the new legislation.
- There have been 11 organisations approved for funding from the Social Change Through Creativity Grants Program from a total funding of \$44,000. Council provides support to organisations to improve social outcomes using creative processes.

- Council continued to host community meetings for seniors, youth, multicultural, family support and disability groups. These meetings focus on various topics such as the changes to grant funding for local community groups and the introduction of the National Disability Insurance Scheme, which will have an effect on community and accessibility to some services.
- Council held a number of significant events across
   Fairfield City such as Harmony Day and Refugee
   Week. Approximately 350 people attended the events which included a range of food and entertainment stalls, a photography exhibition, stories celebrating successes of local refugees and two film screenings of the 'Girl Rising' film in partnership with Immigrant Women's Health Network.
- 'Open your Eyes be Waterwise' Water Safety
  Presentation and the CPR Save Life program was
  delivered to 75 children from 3 schools to spread the
  water safety awareness message and the basic life
  support skills.

- 12 Week Challenges were delivered twice this year, with a total of 100 participants losing a total of 324 kilos.
- Boot Camp were delivered throughout the year with 144 sessions held at Prairiewood Leisure Centre and 72 sessions at Fairfield Leisure Centre.
- Schools Learn to Swim Program held 21 classes for 2376 students at Council's Leisure Centres.

#### AWARDS

- The Bring It On! Festival won the Westpool Local Government Award for Risk Management Excellence.
- Council was awarded the Local Government Youth Week Award during Local Government Week, for Best Local Youth Week Program.

#### **Key Highlights**

- Commenced the multi-million dollar development of the Dutton Lane Car Park for retail shops and car parking spaces which is being developed to assist Council to become more financially sustainable into the future.
- Implemented a Bush Tucker Trail at the Bonnyrigg Town Centre Park which included edible indigenous plants, walking trails, interpretative and way finding signage, indigenous sign boards, and seating at the Aboriginal Elders garden.
- Constructed over eight kilometres of new footpaths and two and a half kilometres of replacement footpaths throughout the City.
- Implemented upgrades to over 16 kilometres of roads throughout the City.
- Constructed an additional 665 metres of shared cycleway in the City with the development at Swager Place between Orphan School Creek and Canley Vale Road, Canley Heights.
- Provided new basketball and badminton courts at Adams Park, Canley Vale, which is another quality recreation facility for the Fairfield community.
- Partnered with Rotary Down Under Incorporated to hold a Graffiti Removal Day in October across Fairfield City working towards make Fairfield a clean and attractive place to live.
- Provided free public transport to areas that are not serviced through its City Connect bus service with over 13,000 community members utilising this service.
- Commenced construction of Fairfield Youth and Community Centre to provide dedicated space for Youth activities and community uses.
- Planted over 190 new trees along Cowpasture Road and Elizabeth Drive, Bonnyrigg Heights
  as part of the Green Streetscapes program working towards a cleaner environment and a more
  attractive City.
- Advocated on behalf of the community to the Federal Government on the impacts of the Badgerys Creek Airport on the lack of funding to local governments for roads.
- Awarded six heritage grants to identified heritage listed residential properties for improvement restoration works in an effort to support the diverse culture and heritage of Fairfield City.



#### PROJECTS

- New air conditioning has been installed at Bossley Park Community Centres.
- Constructed 2,580m of footpath replacement and 8,400m of new footpaths throughout City.
- Implemented 16,100m of road upgrade works throughout City.
- Multi-Deck Car Parks for Nelson Street and Downey Lane Car Parks have been updated including replacement of toilets, wheel stops, renewal of lighting, signage and line marking works.
- Council's Depot on Cardwell Street had a new training room installed to continually enhance the workforce's skills and competencies.
- Bonnyrigg Park Bush Tucker Trail walkway has been constructed including landscaping of edible native plants and educational signage.
- A parking guidance system has been installed at the existing Dutton Lane multi-storey car park.
- Construction of 665m of shared cycleway has been completed along Swager Place between Orphan School Creek and Canley Vale Road.
- The flying fox and play equipment at the Bonnyrigg Town Centre Park is open to the public and includes flying fox, small climbing wall and slide.



- Banner poles and landscaping have been installed at Adams Park Canley Vale and the Mount Pritchard Gateway.
- Gateway entrances into Horsley Park have been constructed including signage and flag poles.

#### SERVICES

- Rosford Reserve athletics field upgrades include lengthening of the run-up, replacement of the rubber surface, removal of contaminated material and replacement of the sand in the sand pit.
- Landscape screening trees have been installed behind some properties in Avonlea Street, Fairfield West to assist reducing the visual impact of graffiti vandalism.
- Council held a Graffiti Removal Day, which was coordinated by Rotary Down Under Incorporated during October in areas such as Hawkesbury and Goodacre Streets, Fairfield West; Endeavour Reserve, Canley Vale; Dawson Street, Fairfield Heights and Gosse Place, Bonnyrigg Heights.



- Over 13,212 community members utilised Council's City Connect Bus Service.
- A total of 80 lineal metres of new pavement has been laid along Park Street and Arthur Street, Cabramatta.
- Council hosted the centenary celebrations at the Cabravale Memorial Park including the installation of a time capsule.
- Two side loader garbage trucks have been replaced to improve Council's services.
- Survey equipment has been purchased to increase Council's surveying and spatial data services to the community.
- Traffic improvement works have been completed including shoulder widening on Ferrers Road, Horsley Park.

- Road improvements on Smithfield Road, between Edensor Road and Gretel Street, Greenfield Park consists of a four-lane-two-way carriageway line marking and new cycle way.
- A new roundabout has been built and is in operation at the Gilbert Street and Conventry Road intersection.
- Raised threshold has been installed on Kalang Road, Edensor Park.



- Kerb blisters and edge line marking have been constructed at St Johns Road, Canley Heights to assist pedestrians to cross the road safely and to discourage motorists from speeding.
- A median island and stop signs have been constructed on the intersection of Bourke Street and The Horsley Drive, Smithfield to improve the intersection and enhance road safety.
- Two speed humps have been installed on Boyd Street, Cabramatta West to deter motorists from speeding.
- Raised threshold on Melbourne Road, St Johns Park and Edensor Park have been installed as a traffic management device.
- Greenfield Park Community Centre has been upgraded to include a front pergola and timber structure.
- Intersection landscaping has been completed at Elizabeth Street and Horsley Drive as part of a beautification project.
- Total of 190 new trees along Cowpasture Road and Elizabeth Drive, Bonnyrigg Heights have been planted as part of Green Streetscapes Program.
- All assets on Councils register have been added into the mapping system.
- Commenced contruction and expressions of interest for retail spaces of the Dutton Lane Redevelopment.



- Administration Building Fountain has been upgraded to comply with the new swimming pool legislation.
- Safety switches have been installed at certain Council buildings to ensure compliance with NSW Workplace Health and Safety Amendment (Residual Current Devices) 2011.

- Fairfield Youth and Community Centre is near completion which includes sports courts, indoor rock climbing and office spaces.
- Hartley Oval and Brenan Park Amenity Buildings have been upgraded including refurbishment of roof, new flooring, timber pergola, and electrical.
- The Youth Refuge in Fairfield has been upgraded including new flooring and electrical switchboard.
- Cabramatta Community Centre and Janice Crosio Child Care Centre have been upgraded including new flooring in the youth and main office and timber pergola.
- Fairfield Leisure Centre's male change room has been upgraded including tiling, ceiling repairs and water saving showers.
- Old Council Building at the Fairfield City Museum and Gallery in Smithfield has been upgraded including new tiling, roof structure and sheeting, and canteen bench.
- Wetherill Park Early Learning Centre, Tasman Parade Childcare Centre and Pevensey Street Family Resource Centre had upgrades including new soft-fall ground, shade awnings and nappy changing facilities.
- Fairfield Tennis Courts have been upgraded including security doors, synthetic resurfacing on court 2, roof repairs to the amenity building and external shade structure.



- Speed hump constructed in Essendon Street, St Johns Park.
- Council has removed a speed cushion in Hughes Street Car Park and Restwell Road, Bossley Park and replaced with two new speed humps in Mitchell Street, Carramar to further improve road safety.
- A raised pedestrian crossing has been constructed on Villawood Road, Villawood.
- A raised threshold has been installed at Candlewood Street, Bossley Park.
- Council has constructed basketball and badminton courts at Adams Park, Canley Vale and is now open for use.
- As part of the Smithfield-Wetherill Park Heavy Vehicle Access Improvement Program, curb alignment was concreted to allow trucks to turn left safely at the intersection along Victoria Street.



- The Fairfield Showground has been upgraded including new mechanical equipment, car park and spectator seating.
- Prairiewood Leisure Centre has been upgraded including renewal of the hypochlorite storage vats, replacement of skirting boards, roof structure over the hypo tanks, cross fit rack, children's pool fountain, and spectator shade and seating.

#### GRANTS

- Council has been successfully awarded \$25,000 in grant funding for the installation of outdoor exercise and gym equipment at Adams Park.
- Council's Heritage Grant program awarded funds to 6 residential properties for improvement works to restore valuable heritage properties.

#### ADVOCACY

 Council has advocated to the Federal Government regarding the lack of funding to Local Governments regarding traffic impacts from the Badgerys Creek Airport.



# ACHIEVEMENTS AND HIGHLIGHTS

## THEME THREE - ENVIRONMENTAL SUSTAINABILITY

## **FAST FACTS**

#### **Key Highlights**

- Generated 970,463 kilowatts in solar power through the installation of 19 solar panel systems on council buildings across Fairfield City ensuring continued efforts to address climate change and reducing the cost of services.
- Installed additional portable CCTV cameras at Yennora, Cecil Park and Wetherill Park, to assist in preventing illegal dumping activities in the City.
- Implemented creek bank stabilisation works and drainage upgrades to improve stormwater outfall at Bromley Street, Canley Vale.
- Received a Highly Commended Award in Excellence in Integrated Stormwater Design for the 'Crossing the Waters' Project, Bibby's Place in Bonnyrigg.
- Held a National Tree Day event involving over 60 volunteer community members planting over 4,500 native plants (from the Community Nursery) next to Fairfield Indigenous Flora
- Cleaned a number of the City's waterways with over 16 tonnes of litter, rubbish and debris collected and removed in an effort to provide a cleaner environment and City.
- Participated in the Western Sydney Regional Asbestos Disposal Scheme, which saw over 7 tonnes of asbestos removed from over 30 homes across the City.
- Conducted over 120 environmental sustainability educational activities throughout the city, teaching over 4,000 local residents from young school children through to the elderly about new ways of doing things that would make them more environmentally sustainable into the future.



#### **PROJECTS**

- Additional portable CCTV cameras were installed at Yennora, Cecil Park and Wetherill Park for illegal dumping activities.
- Council has installed 7 stormwater education signs and 22 creek name signs across Fairfield City.
- Council has installed a total of 19 solar panel systems on council buildings across Fairfield City with a total of 970,463 kWh of solar power generated during the 2014-2015 financial year.



- Council has appointed a new Waste Audit and Education Officer as part of a grants program and has inspected 715 bin bays at multi-unit dwellings across Fairfield City.
- Council has implemented creek bank stabilisation and drainage upgrades at Bromley Street, Canley Vale, which has improved the stormwater outfall.

#### **SERVICES**

- The Floodplain Risk Management Study and Plan for the Canley Corridor has been developed.
- Council has developed a model for a 'One in a 100 Year' flood event, which identified flood behaviour and potential areas at risk of flooding.
- Council implemented the Kids Environmental Education Program, which held 129 educational sessions about environmental sustainability and waste management for 3,445 students from 14 primary schools across Fairfield City.
- Total water consumption for all Council facilities has reduced by 11.2% compared to our baseline.
- The Waste Enforcement Group conducted 548
  hours of patrols and attended 1,537 illegal dumping
  sites across Fairfield City. This created an estimated
  saving of \$15,333 due to the waste removed by the
  offenders.

- National Tree Day was held adjacent to the Flora Park and attracted 62 residents. A total of 4,500 native plants were planted, which were supplied by Council's Community Nursery. Council's Creek Care Program has planted approximately 26,662 plants across Fairfield City.
- A total of 16.2 tonnes of litter, rubbish and debris was removed from the City's waterways.
- Council participated in the Western Sydney Regional Asbestos Disposal Scheme, which removed approximately 7.8 tonnes of legacy non-friable asbestos from 33 homes across Fairfield City by licensed contractors.
- The Community Nursery volunteers accumulated 538 hours for the month February 2015 and 32,000 plants were potted.



- Council's tree branch recycling service mulched over 310m3 of garden waste. The mulch was distributed free of charge to local residents and parks as part of the Open Space Maintenance Program.
- Council ran 6 stormwater educational programs and projects across Fairfield City to local residents and school children. These included educational talks about stormwater, flooding and creeks at Council's Open Day.
- Council has rehabilitated and maintained 1,775,623 m2 of riparian corridors and bushland reserves as part of council's Creek Care Program and Stormwater Levy Maintenance Program.
- New stormwater drainage works at Rosina Street, Fairfield West have been completed to reduce flooding.
- Council engaged 2,707 students from 15 local schools about waste and catchment management as part of the Keep NSW Beautiful program.

 A total of 121 Green Waste vouchers have been redeemed to allow residents to drop off garden waste material to Council's Recycling Drop Off Centre free of charge.



 A total of 125 environmental sustainability educational activities were conducted for 4,080 local residents across Fairfield City about waste management, worm farming, sustainable gardening, and water and energy saving practices.

#### AWARD

 Council has received a Highly Commended Award for Excellence in Integrated Stormwater Design for the Crossing the Waters: Bibby's Place Project.

- Coordinated the Moon Festival celebration with over 90,000 people coming from across Sydney
  to Cabramatta to enjoy the South East Asian colours, flavours and cultures including traditional
  and contemporary performances, lion dances, gourmet food, market stalls and the famous
  children's lantern parade led by the Moon Goddess.
- Implemented a number of improvements to major town centres throughout the City including street tree planting, footpath repairs, landscaping and major upgrades to Villawood shopping centre.
- Awarded the University of Western Sydney's Excellence in Partnership for the Contemporary
  Management Issues Learning Program, which involved working with 3rd year university students
  on research and development issues facing the business community in Fairfield City.
- Held a Lunar New Year celebration welcoming the Year of the Goat and Ram in Cabramatta and Canley Heights where the streets came to life with two days of celebrations of entertainment, traditional rituals and authentic dishes.
- Delivered the Fairfield City Centre Mayoral Business Forum which saw Council engaging with local businesses in order to work together on key issues especially ways to improve the city centre for both businesses and the community.
- Held the 'Culinary Canivale' the Spanish and Latin American food festival which attracted over 10,000 people to celebrate and enjoy food stalls, cultural performers and a show by celebrity chef Miguel Maestre.
- Conducted breakfast workshops 'Make Council Your Business' for local businesses on how they
  can participate in Council's procurement processes in an effort to support our local businesses
  with the purchasing of goods and services.

#### PROJECTS

- Centre improvement works were completed in various locations including:
  - Street tree planting in Fairfield and Polding Streets
  - Footpath repairs in Brenan Street
  - Landscaping in Loscoe Street
  - Major upgrade to Villawood Shopping Centre.

#### SERVICES

 Council held a seminar Find Out How We Can Help You Run Your Small Business Effectively in September at the Fairfield RSL Club. The seminar was supported by Council and hosted by Fair Trading in collaboration with Emerging Communities Action Partnership, Fairfield Migrant Resource Centre and Service for the Treatment and Rehabilitation of Torture and Trauma Survivors.



- Council hosted the 2014 Moon Festival in Cabramatta for 80,000 community members. The event included the Australian Travelling Fishing show, monster trucks, performance by Banana's in Pyjamas and Dami Im from Channel Seven's X Factor as well as Mayor Frank Carbone taking part in the Ice Bucket Challenge to support and raise awareness about Motor Neurone Disease.
- Lunar New Year celebrations in Cabramatta, welcomed the Year of The Goat and Ram for 12,000 community members that joined the fun in Freedom Plaza, Cabramatta. The event was an action-packed weekend filled with entertainment, traditional rituals and some of the most authentic Asian dishes in Sydney.



 Culinary Carnivale is Western Sydney's Spanish and Latin American food festival. This year's event attracted approximately 10,000 community members and included celebrity chef Miguel Maestre, cultural performers and many flavourful food stalls.

- Council has implemented initiatives as part of the Fairfield City Centre Marketing plan, including hosting two local events (Mother's Day and Easter Rabbit), supported the school tours about cultural food businesses, installed Anzac Day banners and delivered the Lifetime Business Awards.
- Council continues to provide strategic economic advice to various stakeholders such as the NSW Trade and Investment, NSW Department of Planning and Environment, Small Biz Connect, Deloitte Douche Tomastsu, NSW South West Sydney Business Chamber Advisory Committee and University of Western Sydney.
- Council delivered a breakfast for local trade's people to advise them on how to participate in Council's procurement processes.
- Council held 16 Place and Economic Development public forums across Fairfield City, such as the Smithfield / Wetherill Park Discussion Group meeting, Bonnyrigg Town Centre Committee and Fairfield City Centre Business Forum.



A Fairfield City Centre Mayoral Business Forum
was held to provide businesses with an update on
city centre capital works and to provide a summary
of the 10 year Centre Improvement Program.
Council's service areas presented to local businesses
about how their service could be a benefit to local
businesses.

#### **Key Highlights**

- Launched a new locally recorded and produced version of the National Anthem Advance
   Australia Fair that is played at all Council meetings and citizenship ceremonies, celebrating
   Fairfield's cultural diversity and individuality.
- Upgraded the availability of online payments to include certificates in an effort to meet the changing needs of the community and making council services more accessible.
- Installed and upgraded the telephone system which was a targeted cost-effective solution for the delivery of Council services.
- Implemented efficiency upgrades at the Showground including LED, solar and sensor lights and low flush toilet systems which all contribute to actions that address sustainability and cost efficiencies.
- Implemented a just-in-time procurement system to reduce paper costs, manual handling and administration in its procurement processes.
- Distributed over 139,000 tonnes of construction materials that were recycled by the Sustainable Resource Centre to both Council services reducing their costs as well as external customers.
- Advocated to Local, State and Federal Members and the Premier for the continuation of pensioner rebates for future years to continue to support its aging community into the future.
- Lodged our Fit for The Future Improvement Proposal supporting Fairfield to remain as a standalone Council.

#### PROJECTS

- Council launched a locally recorded and produced Advance Australia Fair (National Anthem) that will be played at all Council Meetings and Citizenship Ceremonies.
- Council has upgraded its e-Business initiatives that enable online services such as payments for certificates.
- The Long Term Financial Plan incorporated new savings delivered as a result of better calculating Council's depreciation through its Asset Management Plans.
- Council submitted a Fit for Future application to the NSW State Government, which was developed through extensive engagement with the community across Fairfield City.
- Microsoft Lync communications system has been installed to all computers at all Council sites, which allow Council to effectively engage with the community.
- Digital Voice Over IP system has been installed to upgrade Council's telephone system as a cost effective initiative.

#### SERVICES

- Council achieved 100% in all apects of the WorkCover Audit.
- The Sustainable Resource Centre recycled and distributed 139,300 tonnes of construction material for internal and external customers.
- Council's held its annual Open Day which included a range of Council, Community and Emergency Service stalls promoting the different services offered across Fairfield City. The day was well attended by community groups and residents.



- The Mayoral Donations Fund provided over \$7,500 in funding to 15 recipients across Fairfield City for charity and community organisations, local schools and community members.
- The Mayoral Scholarship Fund provided \$8,500 in funding to 8 recipients across Fairfield City for outstanding local students, students with disabilities and a public school.
- The Community Volunteer Fund provided \$3,000 in funding to 3 recipients to support their volunteering contribution to Fairfield City.
- The Councillors Community Fund provided \$4,000 in funding to 5 recipients across Fairfield City for charity and community organisations and local schools.
- The Sustainable Resource Centre reduced its Carbon emissions by 6,543 tonnes.

- System improvements to Council's accounting system have been completed to enable the efficient approval of invoices, real time financial reporting and expense accounting for assets.
- Australia Day was celebrated at a number of events across Fairfield City including the Australia Day Community awards Ceremony, free pool parties at the Fairtfield and Prairiewood leisure centres, and spectacular fireworks display at Canley Heights.
- Council has changed its procurement process into a Just-In-Time system and all council printers are setup for double sided printing, in order to reduce the cost of paper, manual handling and administration across Council.
- The Fairfield City Calendar was developed and distributed to local residents, which highlights community events and activities.




- The Fleet Renewal Program was completed with all light vehicles changed to comply with the Light Vehicle Fleet Policy to ensure the best value and operation for Council.
- A focus on the reduction of leave has been implemeted across Council to minimise the increased costs and risks associated with leave liability.
- As part of the Workforce Management Plan, a profiling tool has been developed and workforce data collected for analysis of role succession and capability risks at Council.
- The Quality Management system has continued to increase in use throughout the organisation and improvements were made to the automation of the system for the development of an improved Quality Management Register.
- Council has developed a Corporate Work Health and Safety (WHS) Strategic Plan with specific Key Performance Indicators and WHS projects aimed to achieve a decrease in lost time injury frequency rate.
- Council completed 22 Productivity Improvements and Cost Containment improvements around staffing, systems, event management, processes, finance, purchasing, water and energy efficiency and fleet.

#### ADVOCACY

- Council has written to Local, State and Federal Members and the Premier to advocate for the continuation of pensioner rebates for future years.
- Council advocated with the State Minister for Family and Community Services, relevant State Members of Parliament and stakeholders to consider new negotiations with the Men's Shed about the design for the new custom made facility, prior to signing the new agreement.





# Diversity and Multicultural Activities

### DIVERSE AND MULTICULTURAL SERVICES

Council supports the migrant, refugee and emerging communities of Fairfield City by building the capacity of the local multicultural services sector and encouraging collaborations between agencies. Council convenes and/or supports various interagencies, partners with community organisations to deliver strategic projects and advocates for equitable funding for the community and the sector. Council convenes the Multicultural Advisory Committee (MAC), an active group of local residents who advise Council on issues that impact on cultural communities.

#### **Projects and Programs**

This year, Council partnered with numerous agencies on projects with culturally and linguistically diverse (CALD) and Aboriginal communities, which includes:

- Villawood NAIDOC Festival 2014 which celebrated Aboriginal and Torres Strait Islander cultures through workshops, performances and activities at Hilwa Park, in partnership with Woodville Community Services.
- A book called 2 On Winter Melon
  was produced in partnership with the
  Vietnamese community by gathering
  childhood stories from Vietnamese elders
  to develop a unique children's book.
- The Kitchen Tables project worked with culturally diverse people from Bonnyrigg

- to document their stories and connections around food, culture and relationships to produce a series of digital stories, in partnership with The Benevolent Society.
- The Choir of Love project was designed to engage culturally diverse residents in nursing homes through song writing and musical workshops to create You Are Not Alone, which is an original multilingual composition drawing on stories and specific song traditions.
- A project about sharing Congolese cultural heritage through music and dance with other communities in Fairfield City was implemented in partnership with the Congolese Community of NSW.
- Te Toi O Nga Rangi is a program to empower local Maori youth through education and cultural activities in partnership with the Daystar Foundation.
- Council partnered with Vocational Education and Training Assess (VET), Parents Café, Department of Human Services and South-West Sydney TAFE to deliver a workshop to assist refugees to undertake a skill assessment test with the aim to have these skills formally recognised in Australia.
- Council supported NSW Spanish Latin American Association for Social Assistance (ALASA) in a program to mentor, support and provide culturally appropriate information to the Ahwazi community a minority ethnic group from Iran that have settled in Fairfield City.



- Council delivered a symposium on bilingualism and intercultural communication for local residents in partnership with Western Sydney University. The project was able to share experiences from experts about the potential and challenges of raising bilingual children.
- In partnership with FORM Dance, Council
  participated in the Show It Off workshops to
  produce show marketing reels to support festival
  organisers, which attracted local folkloric cultural
  performing groups across Fairfield City.
- Council provided case studies and supported the Australian Centre of Excellence for Local Government in developing a new online resource tool *Building Social Cohesion in Our* Communities, which was developed as part of the National Anti-Racism Strategy.
- Council supported the Parents Café to establish a new social turf management enterprise for refugee men to assist them in generating an income while addressing the stress placed on men dealing with a considerable change upon arriving in Australia.
- Council supported social Angkor Flowers and Crafts initiative to train women in flower arranging skills.
- National Reconciliation Week was delivered in partnership with Council's Aboriginal Advisory Committee to educate residents about our shared histories, cultures and achievements, and contributing to building a reconciled Australia. The event included Uncle Greg Simms giving a Welcome to Country in Darug language and Uncle Wes performed a purifying smoke ceremony.

- Council supported four local multicultural organisations to deliver With Courage let us all Combine events across the Fairfield City for Refugee Week.
- Fairfield City Museum and Gallery celebrated its inaugural Harmony Day 2015 featuring performances, activities and stalls from community organisations including the Dutch Cultural Alliance, Australian Croatian Folkloric Group and Candombe Yauguru.

#### Advocacy

State and Federal Governments introduced significant policy and funding changes to a range of programs, including settlement grants, building multicultural communities program, healthy ageing programs and emergency relief. These changes affected local multicultural services and organisations who have had to reduce services and staff.

Council undertakes a strong advocacy approach to ensure the needs and circumstances of the residents of Fairfield City are presented to the government. Council advocated to Parliamentary Inquiries and Ministers on changes to funding, viability of local organisations and accessibility of services.

Council continues to support advocacy actions undertaken by the local community by attending a range of consultations about changes to legislations and programs. These include:

- Aged Care Reform
- · Disability Inclusion Bill and Act
- NSW State Disability Inclusion Plan
- National Disability Insurance Scheme

Council's Access and Equity Activities are activities that benefit the broad community by promoting fairness in the way we distribute our resources and services, recognising the community's cultural and religious rights, and providing the opportunities to participate in consultations to determine our future direction.

## Access and Equity Activities

Council partnered with many community organisations in order to deliver these activities. The following provides an overview of access and equity activities Council has undertaken:

- Council continued to provide rate rebates to eligible pensioners in Fairfield City.
- Seniors are offered free entry to Fairfield City Council's Leisure Centres during non-peak hours.
- Council implemented the Access Improvement Program and has upgraded the toilets and kitchens at Edensor Park community buildings to ensure the out of school hours service operating from the facility complies with National Accreditation Requirements for access.
- Council has received Disability Standards
   Accreditation after undertaking a Verification
   Audit to check compliance against the
   Disability Standards in order to comply with
   the National Disability Insurance Scheme
   (NDIS).
- A staff member has been employed to support Home and Community Care (HACC) Services by providing specialist advice and is responsible for the implementation of the Disability Access Plan.
- In partnership with Cabramatta Community Centre, a youth disability project Side by Side was delivered to raise awareness of barriers faced by young people with disabilities.
- Planning Ahead Program trained and educated community members in their own language to plan their personal affairs ahead of time before their mental competency to make decisions declined due to illness or age.
- Council supported a Carers' Week event for local carers.

- As part of International Day of People with Disabilities, Council held an expo for local community members with disabilities. Clients from disability services, local special schools and members of the community participated in the event.
- The Seniors Week Fair provided opportunities for seniors, carers, their families and the community to find out about local services, gain knowledge of issues of importance and experience the benefits of healthy lifestyle activities.
- The new Fairfield Youth and Community Centre has been designed to meet existing access requirements.
- Council has implemented an internal audit for access across 18 facilities such as Council's child care centres, libraries and museum.
- Council's libraries provided training for mature workers to assist them to re-enter the workforce.
- Educational workshops about disability reform were hosted for residents and service providers across Fairfield City.
- In partnership with the Heights Community Services, the Healthy Food Programs were provided for people with disabilities on a low income to educate the community about eating healthy on a budget.
- Council Provided a Nutrition Program for older people in partnerships with Heights Community Service.
- Educational sessions held for Carers of People with Alzheimer's partnership with Parks Community Network Inc.
- Council provided educational programs and resources about the implementation of National Disability Insurance Scheme for Vietnamese parents who have a child with disabilities.



## COMPLIANCE WITH THE NSW CARERS (RECOGNITION ACT 2010 AND NSW CARERS CHARTER

Fairfield City Council recognises the valuable social and economic contribution that carers make to the community and the people for whom they care for in line with the NSW Carers (Recognition) Act 2010 and NSW Carers Charter.

#### **Resident Carers**

Council widely consulted service providers and carers. The findings from the consultations have been included in the Strategy on Ageing for Fairfield City 2013–2017 and Council's Disability Action Plan.

#### **Council Staff Carers**

To Comply with the NSW Carers Act 2010, Council conducted a staff survey and 85% of respondents indicated satisfaction with the level of support provided by Council.

Council has in place a Carers' Leave Policy that supports staff who are required to care and support a family member (or a member of the employee's household) who is ill or who requires care as a result of an unexpected emergency.

#### **DISABILITY INCLUSION ACT 2014**

The Disability Inclusion Act 2014 replaces the Disability Services Act 1993 and increases the rights, protections, inclusion and safeguards for people with disabilities. The Disability Inclusion Act requires local Councils to put in place a Disability Inclusion Action Plan to promote the inclusion of people with disability.

Council is preparing for the development of the Local Disability Inclusion Plan by undertaking a review of disability access of council facilities, major parks and major commercial business centres. In addition, an Access Audit Review has been conducted on child care facilities, libraries, and the Museum and Gallery.



# Environmental and Planning Activities

## COMPANION ANIMAL ACT AND REGULATION ACTIVITIES

Council is required to report a detailed statement of activities relating to enforcing and ensuring compliance with the Companion Animal Act and Regulation.

## Lodgement of pound data and returns with the Office of Local Government

A total of 1,380 animals were impounded during the last financial year, which was made up of 590 cats and 790 dogs.

### Seeking alternatives to euthanasia for unclaimed animals

After impoundment, Council's Animal Shelter - Renbury Farm reviews each seized animal and explores alternative options, such as sending to rescue home, animal adoption or foster care, before any decisions are made in regard to the destruction of an animal. A total of 1,092 animals were rehomed, which was made up of 707 dogs and 385 cats.

### Lodgement of data about dog attacks with the Office of Local Government

Council reports dog attacks to the Office of Local Government, by the Companion Animal Register, within 72 hours of being notified of the attack. Last financial year 68 incidents were reported.


## Expenditure on companion animal management and activities

In 2014-2015, \$243,879.93 was spent on the management of companion animals and related activities.

## Companion animal education programs and desexing initiatives

Council has implemented community education programs, and promoted and assisted in the desexing of cats and dogs, which included:

- Free microchipping days for dogs and cats were held during this financial year.
- Operation Cat Program was held in September 2014 and May 2015 which offered Fairfield City residents discounted de-sexing and microchipping.
- A Discounted Desexing Program for cats and dogs was promoted on Council's website.
- Notifying all local vets and the Animal Welfare League of all firework displays to be conducted in the area and providing information on Council's webpage.



#### Council's off leash facilities

Council continued to provide two off leash areas, which are at Freeman Avenue Reserve on Railway Parade, Canley Vale and King Park on the corner of Kembla Street and Townsville Road, Wakeley. Both off leash areas have public seating and are fenced. These areas are provided with degradable doggie poo bags, a waste bin and a self-filling drinking bowl for dogs, and are regularly maintained.

#### ENVIRONMENTAL UPGRADE AGREEMENTS

Fairfield City Council did not enter any environmental upgrade agreements under S406 in 2014-2015.

### BUSHFIRE HAZARD REDUCTION ACTIVITIES

There was no requirement to carry out any bushfire hazard reduction activities during the year.

#### STORMWATER LEVY

Council's Stormwater Levy program is funded from a charge levied on all rateable properties in Fairfield City. The program provides an additional source of funding for stormwater management projects.

In 2014-2015, \$1.51 million was raised by the Stormwater Levy, of which approximately \$1.34 million was spent on a mix of planning, design, construction, maintenance, education and research projects as outlined in the table below.

#### PLANNING AGREEMENTS

A Voluntary Planning Agreement (VPA) is an agreement entered into by a planning authority (such as Council or NSW Department of Planning & Infrastructure) and a developer. Under the agreement a developer agrees to provide or fund:

- · Public amenities and public services
- · Affordable housing
- · Transport or other infrastructure
- · Dedication of land contribution
- · Monetary contributions
- Construction of infrastructure contributions
- · Materials for public benefit and/or use

VPAs cannot be entered into unless public notice has been given and an explanatory note is made available for inspection for at least 28 days. VPAs now on public exhibition, in the process of being finalised or have been executed are:

- · Bonnyrigg Living Communities VPA
- Calabria Club VPA
- · Fairfield Chase VPA
- 83-85 The Crescent, Fairfield VPA

#### **Bonnyrigg Living Communities VPA**

The Bonnyrigg Living Communities Project involves the redevelopment of the Housing NSW estate in Bonnyrigg over 18 years. The VPA with Bonnyrigg Partnerships covers the developer contributions for the project.

Bonnyrigg Partnerships worked with Becton Property Group in the redevelopment of the estate and delivery of the VPA works. After Becton Property Group went into receivership, Bonnyrigg Partnership sought a replacement company to undertake the redevelopment and deliver the VPA. While this was occurring during the 2014/15 period, no construction occurred on either the development or VPA deliverables.

#### Calabria Club VPA

The Voluntary Planning Agreement required the dedication of land for open space by the developer to Council. Council is then required to embellish the land, which includes weeding and re-vegetation.

The Certificate of Title has been signed off with dedication to occur once land is registered. Embellishment and planting by Council will occur once registered.

#### **Fairfield Chase VPA**

The Voluntary Planning Agreement requires the development contribution payment for the provision of additional car parking within the Fairfield Town Centre. The contribution must be paid before the release of the construction certificate, which allows construction of the development to proceed. Council is then required to provide additional car parking or embellish existing car parks to make them more useable.

As yet, the development consent has not been acted on and no development contribution has been paid to Council.

#### 83-85 The Crescent, Fairfield VPA

The Voluntary Planning Agreement addresses the shortfall of two car parking spaces associated with development of this site. The developer made an offer to enter into a planning agreement to provide financial contribution to Council and to assist in covering the cost increase of public parking or improve the quality of existing parking areas. The development contribution has been paid to Council.



## Workforce Management Plan Activities

#### WORKFORCE MANAGEMENT PLAN

Council's Workforce Management Plan, known as Our People, Our Future: A Human Resources Strategic Plan 2013-2022, is a key component of the resourcing strategy that supports the delivery of Council's services, initiatives and major programs. It ensures Council has the right workforce skills, attributes, capabilities and strategies in place to meet community expectations now and in the future.

The vision for this Plan is that Council achieves a well-earned reputation among staff, the labour market and the sector, as 'A great place to work – a great community to serve'.

The Plan builds on existing workforce programs, actions and successes. It includes five key strategies, translated into interrelated programs, to meet specific community and organisational priorities. These strategies are:

Each program is underpinned by priority objectives and actions. These objectives and actions are the result of consultation with Council staff, evaluation of the Local Government sector and analysis of future industry trends/challenges that will impact on the organisation.

## Human Resources Strategy and Operations

Council has focused on improving human resources strategies, as well as continuing to meet operational requirements through



service delivery to optimise organisational performance. A number of key priorities for Council include:

- Terminating of Council's Enterprise Agreement and change of employment conditions in accordance with Local Government (State) Award.
- Reviewing the Recruitment and Selection Policy and Guidelines and incorporate training into the Corporate Training Calendar.
- Restructuring business units to improve efficiency across Council.
- Reviewing key human resources policies including Appropriate Workplace Behaviour and Flexible Work Arrangements policies.
- Delivering continued work experience to support the Local Employment Policy.
- Managing the Annual Leave Liability through policy review and annual leave plans for employees with an entitlement of 8 weeks leave.
- Developing a profiling tool for identification of critical roles and development of succession plans.
- Managing Council's Payroll System including Time and Attendance Feasibility Study and production of customised reports for business analysis.

## Simplification of Work Health and Safety Management System

Further simplification of the Work Health Safety Management System (WHSMS) has been completed, which has ensured continual improvements and ease of system implementation by the organisation. New technology has been utilised to deliver online system training across the organisation.

#### Work Health and Safety Audit

This year saw the completion of the current three year audit schedule, incorporating both internal auditing and external compliance audits. A new audit schedule has been developed for the next three year period, which includes new internal audit tools. The next anticipated WorkCover Self-Insurer Audit is June 2017.

#### Work Health and Safety, and Self Insurance

The Workers' Compensation Branch has ensured compliance with the 2012 amendments to the workers compensation legislation. Injured workers are returning to work as per our Injury Management and Return to Work Program that ensures staff are rehabilitated in a timely manner and returned safely back into the workplace.

#### Lost Time Injury Frequency Rate



Above is a graph reflecting Council's Lost Time Injury Frequency Rate (LTIFR). There has been a decrease in the number of Lost Time Injuries (LTI) compared to the previous reporting period. This has resulted in a 20.73% decrease in Council's LTIFR.

#### WHS POLICY

As a result, at Fairfield City Council, we are committed to develop, implement, review and continually improve the Work Health and Safety Management System (WHSMS) compliant with the Work Health and Safety (WHS) Act 2011 and WHS Regulation 2011, WorkCover National Self Insurer OHS/WHS Audit Tool, relevant Codes of Practice, Australian Standards and statutory requirements.

At Fairfield City Council, safety is not negotiable. We are all responsible for our own health and safety and those around us in the workplace.

#### **POLICY OBJECTIVES and** COMMITMENTS

This policy is applicable to Council and all its operations and functions. Fairfield City Council is

- Complying with relevant health and safety legislation and other requirements placed upon the Council or to which the Council subscribes;
- Establishing measurable objectives and targets for health and safety to ensure continuous improvement aimed at elimination of work related illness and injury;
- Reducing the impact of occupational injury, illness and disease through the reduction of Lost Time Injury Frequency Rate (LTIFR) and average Loss Time Rate (LTR) per annum;
- Ensuring all workers are included in the decision making processes impacting on workplace health and safety:
- Providing the right of a worker to cease unsafe work:
- Developing and implementing a Risk Management Program consistent with the nature of our workplace activities and scale of health and safety risks;

- Authorising all workers to take the actions required to maintain a safe workplace and to fulfill the WHS responsibilities allocated to their position/level;
- Providing adequate facilities for the welfare of workers
- Maintaining safe plant and structures (including buildings, masts, towers, framework, pipelines, infrastructure, underground works, shafts and/or tunnels);
- Providing information, instruction, appropriate WHS training and supervision to workers to ensure safety in workplace operations;
- Disseminating health and safety information to relevant suppliers, regulatory authorities, and visitors to the workplace as appropriate; and
- Effectively implementing this policy through the development and implementation of a WHS Management System (WHSMS).

#### WorkCover Mentor Program

The WorkCover Mentor Program assists small businesses to improve workplace safety as well as competitiveness and productivity. Fairfield City Council continues to participate in the WorkCover Mentor Program to provide assistance and guidance to local businesses in achieving improvement in their Work Health and Safety obligations.

#### Organisational Development and Learning

Council's Culture and Leadership Program is an ongoing initiative adopted by the City Manager and Executive Leadership Team. The program focuses on our established leadership competencies, which aim to achieve Council's mission and strategy.

A number of key priorities for Council in 2014-2015 included:

- Implementation of the Emerging Leaders Program.
- Delivery of specific training programs which met the needs of individual groups as a result of council wide training needs analysis.
- Development of a training program to support supervisors in leading and managing Council's workforce.
- Providing cultural awareness training to individual work teams.
- Delivery of Appropriate Workplace Behaviour Training to new and existing employees.
- Implementation of a new Learning Management System (WHSMS)

## DIVERSITY AND EQUAL EMPLOYMENT OPPORTUNITY

A committee of Business Unit Managers from across Council has been established to monitor implementation of the Diversity and Equal Employment Opportunity Strategy (DEEOS). Strategic actions have been identified to address issues relating to Council's ageing workforce profile. These actions will be incorporated into the DEEOS for ongoing monitoring and management.

Council's policies: Appropriate Workplace Behaviour Policy and Guide, as well as the Performance Management and Disciplinary Policy and Guide, deal with the prevention of discrimination, bullying and harassment in the workplace. Council continues to provide workforce education and training in the prevention of discrimination, bullying and harassment in the workplace.

A review of the Recruitment and Selection Policy, Guide and Training Package has been completed. The policy ensures a merit-based recruitment process for permanent positions, including best practice in Equal Employment Opportunity principles.

- Proactive release Council is encouraged to proactively release as much government information as possible, in an appropriate manner and free-of-charge (or at the lowest reasonable cost).
- Informal release Council is encouraged to release information in response to a request without the need for a formal application, unless there are good reasons to require
- Formal access application In limited circumstances, access to information will require a formal access application. People have a right to access information in this way unless the GIPA Act provides a reason to withhold the information.

- Promote international understanding and provide opportunities for residents to experience the culture of the sister cities so they develop greater awareness, tolerance and understanding of other cultures
- Give young people the opportunity to develop leadership skills and experience different cultures
- Develop business and economic relationships between the sister cities and Fairfield so the City and community benefit financially.

During 2014-2015 a meeting of the Sister City Committee was held.

The summary does not include cases relating to workers' compensation and insurance matters. There were 8 workers' compensation matters from previous years that continue to be litigated. During the year, 3 new litigated matters arose with 3 matters being settled, leaving 8 matters to continue into 2014-2015.

There were 104 public liability and professional indemnity claims brought forward from previous years; 60 new claims for the period, with 40 being finalised and 124 continuing into 2014-15. These claims are mainly dealt by Council staff with three claims having progressed to litigation.



#### NATIONAL COMPETITION POLICY

Council has adopted the Principle of Competitive Neutrality to its business activities as part of the National Competition Policy, which is applied at all levels of government. The purpose of competitive neutrality principles is aimed at eliminating any net competitive advantages accruing to government businesses as a result of public sector ownership. Such action removes potential market distortions and promotes an efficient allocation of resources between public and private businesses.

The Pricing and Costing for Council Businesses: A Guide to Competitive Neutrality issued by the Office of Local Government has also been adopted. This guide outlines the process for identifying and allocating

costs to activities and provides a standard disclosure of requirements. These disclosures are reflected in Council's pricing and/or financial reporting systems and include taxation equivalents, Council subsidies, return on investments (rate of return) and dividends paid.

#### **Declared Business Activities**

In accordance with Pricing and Costing for Council Businesses: A Guide to Competitive Neutrality, Council has undertaken a review of its business activities. It was determined that only the Sustainable Resource Centre (a facility that recycles used road materials) meets the requirements as a business. The centre falls into Category 1, where business activities gross over \$2 million per year.

#### **CONDITION OF PUBLIC WORKS**

Fairfield City Council is responsible for effectively managing an extensive range of assets valued in excess of \$1.4 billion, which comprises roads, water and sewerage assets, drains, bridges, footpaths, public buildings, recreational facilities, and parks and gardens.

Council's Asset Management Plan, which forms part of our Resourcing Strategy, is a long-term plan that outlines the asset activities for Council and details how we will maintain and manage our assets in a cost-effective way. Council has reported on the condition of its major assets in the table below, which includes asset condition, estimated replacement value, yearly depreciation, estimated cost to bring each asset class up to a satisfactory standard, and annual maintenance requirements as at 30 June 2015.

## Current Achievements and Status of Council's Assets

- Public Roads Council maintains 680 kilometres of roads throughout Fairfield City. The average road condition is considered to be of good standard.
   2.2% of the road network is considered to be in poor condition.
- Kerb and Gutter Council maintains 1,213
  kilometres of kerb and gutters throughout our City.
  The average road condition is considered to be of
  good standard. 1.0% of the kerb and gutter network
  is considered to be in poor condition.
- Building Council owns and controls about 254 buildings and facilities including various substructures. The following is a cross section of Council's holdings: Council administration offices, community halls, libraries, childcare centres, amenity building, public toilets, shelter and cottage. The average condition is considered as good with 2.7% of the building assets/components in poor condition.
- Bridge and Culvert Council maintains 50 bridges and 37 culverts throughout our City. These assets are inspected regularly. No major upgrade other than routine maintenance is currently required.
- Footpath Council maintains 935 kilometres of footpath and cycle ways throughout our City. The average footpath condition is considered to be of good standard. 0.6% of the footpath network is considered to be in poor condition.
- Stormwater Drainage Council maintains 464 kilometres of stormwater pipe and 13,450 stormwater pits throughout our City. The average condition of these assets is considered to be of good standard with 0.3% of the assets in poor condition.

#### WORK CARRIED OUT ON PRIVATE LAND

Fairfield City Council did not have any resolutions made to carry out any works on private land under Section 67 in 2014-2015.

#### CONTROLLING INTERESTS IN COMPANIES

Council held no controlling interest in any company for the 2014-2015 reporting period.

#### RATES AND CHARGES WRITTEN OFF

Rates and charges totaling \$3,154,618 were waived or written off during the 2014-2015 in accordance with the Local Government Act 1993. This compares to rates and charges of \$3,158,002 waived or written off in the 2013-2014 period.

## PRODUCTIVITY IMPROVEMENT, COST CONTAINMENT AND REVENUE OPPORTUNITIES

Council has an active program developing and implementing initiatives focussed on productivity, cost containment and revenue opportunities. Council continually searches for opportunities that would result in a more positive operating position. The key initiatives undertaken during financial year 2014-2015 are:

- Commenced construction of the Dutton Lane Development (commercial operation to generate ongoing revenue).
- Commenced construction and sales of the Diamond Crescent subdivision.
- Planning applications developed and lodged for subdivisions in The Avenue, Canley Vale, and Wetherill Street, Wetherill Park.
- Negotiations relating to the Enterprise Agreement were finalised with the Enterprise Agreement being discontinued and employment conditions reverting to the Local Government (NSW) Award 2014.
- Design completed for improvements to the Sustainable Resource Centre access and weighbridge arrangements. Council's roads program costs are lower as less material diverted to landfill waste facilities and through the use of recycled road materials (less virgin excavated material required to be sourced).
- Just In Time procurement implemented minimising stock held in stores and associated management requirements.
- Print room operations business case completed and adopted for implementation as leases expire.
- Community bus service modified to reduce number of buses held by Council through access to private provider.
- Vendor Panel for trade services adopted and implemented.
- Review of legal services delivery completed.
- Completed review of depreciation and asset life cycles in line with industry practice.

The Fit for the Future program instituted by the NSW State Government has set a framework for local government performance. As part of Council's response to the Fit for the Future submissions to the Independent Pricing and Regulatory Tribunal, Council reviewed and updated its Long Term Financial Plan, including the productivity and cost containment initiatives being examined.



#### SPECIAL RATE VARIATION

The 2001 Special Rate Variation (SRV) expired in June 2014 with a new Special Rate Variation introduced from July 2014. The 2014 SRV extends Council's asset renewal funding, with initiatives targeted at roads, sportsgrounds, parks and drainage. Specific one-off initiatives included are the upgrade of the Prairiewood Leisure Centre Water Park, renewal of the Fairfield Branch Library, Streetscape Improvements in Cabramatta and Fairfield Heights, and a new urban plaza in Fairfield City Centre.

The following table outlines the approved program of works, the expected outcomes for 2014/15 and 10 year program forecast. The following work was undertaken within the program as follows:

- The Fairfield Library Expansion delivery methodology was reviewed with a new site located in Hamilton Road and an existing building purchased. The existing library will continue until the existing commercial leases expire.
- Fairfield City Plaza (The Crescent Plaza) development application was lodged for construction in 2015/16.
- Footpath Connections were constructed in Oxford and Stimson Streets in Smithfield connecting residents to the Smithfield Town Centre.
- Landscaping Park Frontages were completed for Adams Park (Sackville Street and Canley Vale Road, Canley Vale), Edensor Park (Cowpasture Road and Elizabeth Drive, Edensor Park), Mt Pritchard (Elizabeth Drive, Mt Pritchard at the corner of Reservoir Road closest to Cabramatta Creek) and Carramar (Hume Highway and Horsley Drive, Lansvale).
- Community Buildings focussed on the renewal of building services at Prairiewood Leisure Centre with investigations and project scoping for the renewal of air conditioning plant and equipment and the upgrade of the electrical substation completed.
- The funding for the Sportsground proposal was to allow early design work to be undertaken. After reviewing the program for 2015/16, this was not required.

 The Prairiewood Water Park renewal project finalised the scope and budget for the project, with the Stingray surf simulator purchased and tenders for the supply and installation of the major equipment completed.




#### FINANCIAL STATEMENT AND AUDIT
